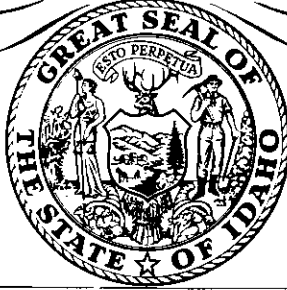

CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho do hereby certify that the original of the articles of incorporation of

One Thousand Nine Hundred **Sixty-two** and duly recorded on Film No. **119** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

ARTICLES OF INCORPORATION
OF
SCHADE AND BAIN, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned incorporators, all being of full age, citizens of the United States and residents of Canyon and Ada Counties, State of Idaho, do hereby certify that we have this day voluntarily associated ourselves together for the purpose of forming a corporation under and in compliance with the laws of the State of Idaho, and do hereby adopt the following ARTICLES OF INCORPORATION, to-wit:

ARTICLE I.

The name of this corporation shall be and is SCHADE AND BAIN, INC.

ARTICLE II.

The purposes for which this corporation is formed are the following:

(a) To engage in the business of owning, operating and/or otherwise dealing in the sale and distribution of petroleum products, vehicle supplies and accessories, machinery and equipment, and chemical products of any type or kind, both on the wholesale and retail level, and as a jobber.

(b) To engage in the business of the sale of any type of goods, wares or merchandise, either upon the retail or wholesale level.

(c) To engage in the business of the manufacture or assembly of any type of product.

(d) To buy, sell, own, hold, lease, improve and deal in real estate or personal property of any type and description, whether or not the same is used in connection with any of the purposes of the corporation listed herein.

(e) To acquire, own, hold, lease, build and/or erect any and all buildings, structures and plants that may be deemed suitable to the furtherance of the foregoing or any purposes for which the corporation is formed, and to operate, manage, control, rent, sell or otherwise dispose of the same.

(f) To incur indebtedness in such amount as may be deemed necessary, and to borrow money; to evidence such or any indebtedness by the bonds or other written obligations of the corporation; and to secure the payment thereof by mortgage, deed of trust, or other form of encumbrance upon all or any part of the property, real or personal, of the corporation, whether owned at the time or afterwards to be acquired.

(g) To carry on any activity or activities that might be related to any of the above described powers of the said corporation.

(h) To do such business not only within the State of Idaho, but in any part of the world, as may be deemed and determined by the board of directors from time to time, without limiting any of the objects and purposes aforesaid. It is expressly declared that the corporation shall have and possess all the powers specifically hereinabove enumerated, and also any and all such additional or further powers as may be incidental to the carrying out of the same, and also such other rights, privileges and powers granted by the laws of this state to corporations, except such as may be inconsistent herewith; the intention hereof is expressly declared to be that the powers of this corporation as expressed herein shall be construed as a grant of general powers and not in any sense as a grant of special or limited powers.

(i) To acquire, invest in, own and dispose of the capital stock of this corporation and of other corporations, and the business property and assets of any person, copartnership or corporation.

ARTICLE III.

The principal place of business and the place where the principal office of the corporation shall be is hereby designated as 1320 North Orchard, Boise, Ada County, Idaho.

ARTICLE IV.

The existence of the corporation shall be perpetual.

ARTICLE V.

The number of directors of this corporation is hereby fixed at three.

ARTICLE VI.

The capital stock of this corporation shall be One Hundred Thousand Dollars, to be divided into 1,000 shares of non-assessable common stock of the par value of \$100.00 per share.

ARTICLE VII.

The amount of capital stock actually subscribed is the sum of \$400.00, and the same has been subscribed by the persons whose names appear hereto as incorporators, and they have subscribed to the following shares: August H. Schade, one share, 312 West Sheridan, Nampa, Idaho; Wilma B. Schade, one share, 312 West Sheridan Avenue, Nampa, Idaho; Floyd C. Bain, one share, 3500 Tulare Drive, Boise, Idaho; Joan H. Bain, one share, 3500 Tulare Drive, Boise, Idaho.

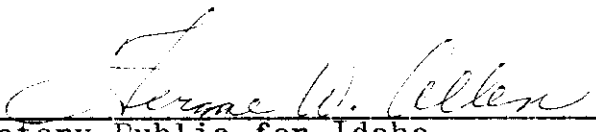

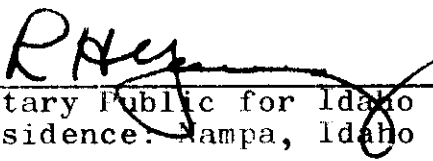
