The undersigned, acting as incorporator of a corporation under the laws of the State of Idaho, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is C C Cabinets, Inc.

SECOND: The period of duration of this corporation is perpetual.

THIRD: This corporation is organized for the purposes of conducting any and all lawful business.

FOURTH: The aggregate number of shares which the corporation shall have the authority to issue is 10,000 shares, of one class of common stock only, without par value.

The initial directors shall serve until the first annual meeting of shareholders or until their successor or successors shall be elected and qualify.


EIGHTH: The corporation has one incorporator whose name and address is:
