RE: *Glacier Bank, Kalispell, Montana – Merger of Bank Subsidiaries*

Dear Ms. McDermott:

The Idaho Department of Finance (Department) has received and reviewed your email and its attachments dated April 17, 2012 requesting approval of the trade names "Citizens Community Bank, a division of Glacier Bank" and "Mountain West Bank, a division of Glacier Bank" for use in the state of Idaho.

We understand that Glacier Bancorp, Inc. intends to merge all of its eleven bank subsidiaries into one subsidiary, with Glacier Bank, Kalispell, Montana as the resulting bank. We further understand that the ten merging banks will continue to operate as divisions of Glacier Bank, under assumed business names following the close of the merger on April 30, 2012.

Section 26-1202 of the Idaho Bank Act prohibits any person, not authorized to operate as a bank under the Act, to advertise or use as part of its company name the word "bank" or "banker" or any other word of similar import. However, Glacier Bank and its holding company, Glacier Bancorp have been authorized to conduct banking business in this state. Additionally, Glacier Bancorp has acquired two banks which formerly held Idaho bank charters, Citizens Community Bank and Mountain West Bank. The two banks will be merged into Glacier Bank. Under these circumstances, the Department does not object to your client's use in Idaho of the trade names "Citizens Community Bank, a division of Glacier Bank" and "Mountain West Bank, a division of Glacier Bank."
