**ARTICLES OF INCORPORATION
OF
SHERRER CONTRACTING, INC.**

KNOW ALL MEN BY THESE PRESENTS:

We the undersigned incorporators pursuant to the provisions of the Idaho Business Corporation Act do hereby certify and adopt the following articles of incorporation:

ARTICLE I. The name of the corporation is **SHERRER CONTRACTING, INC.**, hereinafter referred to as the corporation.

ARTICLE II. The period of the corporation is perpetual.

ARTICLE III. The purpose of the corporation is to transact any and all lawful business as provided for by the Idaho Business Corporation Act, including but not limited to the transacting, contracting, bidding, handling, harvesting, transporting, or in any way or manner dealing with any and all wood products and/or forest products including but not limited to yew wood.

ARTICLE IV. The aggregate number of shares which the corporation shall have authority to issue is Ten Thousand and no/100 (10,000.00) shares. These shares shall consist of one and only one class and shall be without par value. The holder of each share shall be entitled to one vote.


