ARTICLES OF INCORPORATION  
of  
D. T. PRODUCTION COMPANY, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS that we, citizens of the United States of America, of full legal age, having this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho and to that end do hereby adopt Articles of Incorporation as follows:

ARTICLE I

The name of the proposed corporation is D. T. PRODUCTION COMPANY, INCORPORATED.

ARTICLE II

The nature of the business and the objects and purposes proposed to be transacted, promoted, and carried on are to do any and all things herein mentioned, as fully and to the same extent as natural persons might or could do and in any part of the world, to-wit: to provide consultation and advice on programming, technical, financial, and policy matters relating to and existing and proposed radio or television broadcast outlets, to conduct research and to investigate communication media throughout the world in order to secure information and data relevant to the planning and operation of radio or television broadcasting outlets, to print, distribute, and sell material, information, tapes, manuals, and other items which may be useful to those involved in the ownership and operation of

broadcast outlets; to buy, sell, lease, or otherwise deal in property, both real and personal, information, technical equipment, transmitting, reception, and recording devices used for the broadcast outlets or sound studios; to provide personnel, and advisory services on operating policies, methods of subsidizing, and coordination of one or more communication or broadcast outlets, and to engage in the business of communicating, transmitting, receiving, by any method now in use or hereafter discovered, to own, operate one or more radio or television broadcast outlets as licensed by the Federal Communications Commission or any other appropriate regulatory agency.

To carry on the business of promoters of pageants, drama, music, and theatrical productions, providers of public entertainment, concert and public exhibitions, ballets, bands, orchestras, symphonies, and other variety entertainment, and to provide and produce, and present to the public all types of shows, amusements, and productions.

To establish, operate, own, sell, lease, or dispose of public and private installations, theaters, inns, restaurants, bars, grills, entertainment centers, and to engage in all activities, to render all services, and to buy, sell, use, handle, and deal in all fixtures, machinery, apparatus, equipment, accessories, tools, materials, products, and merchandise incidental or related thereto or in the use thereof; to manufacture, produce, and otherwise acquire, distribute, sell, exchange, otherwise dispose of, handle, market, store, import or export, deal in or trade in food products, wines, liquors, beer, and drinks and beverages of every kind and description, printed material, smoking supplies, magazines, newspapers, and all similar kindred and allied articles, products, and merchandise.

To do every thing necessary, proper, advisable, or convenient for the accomplishment of the purposes herein above set forth, and to do every thing else incidental to them or connected with them which is not forbidden by the laws of the State of Idaho.

To acquire by purchase, lease, or otherwise hold, own, sell, or lease, or mortgage, or otherwise dispose of, all mobile and stationary equipment, vehicles, inventory, supplies, raw materials, goods, and products wheresoever situated or being, and to do whatsoever property may be incidental to such business, to engage in contracting, supply, and delivery, to make estimates for itself or for others, and to bid upon, enter into and carry out contracts for the production, accumulation, supplying, and delivery of all merchandise, supplies, products, and materials associated with the business to private parties, contractors, subcontractors, utilities, municipal corporations, municipal contractors, to acquire, hire, employ, sell, and deal in all suitable means, apparatus, machinery, contrivances, equipment, and facilities for the prosecuting of its business.

To take, own, hold, deal in, mortgage, or otherwise lish, to lease, sell, exchange, transfer, or in any manner whatsoever dispose of real property within or without the State of Idaho, wheresoever situated.

To manufacture, purchase, or acquire in any manner and to hold, own, mortgage, pledge, sell, transfer, or in any manner dispose of, and to deal and trade in goods, wares, merchandise and property of any and every class and description in any part of the world.

To acquire the goodwill, rights, and property, and to undertake the whole or any part of the assets, or liabilities

of any person, firm, association, or corporation, to pay for the same in cash or the stock of this company, or bonds or otherwise to hold or in any manner dispose of the whole or any part of the property so purchased, to conduct any lawful manner the whole or any part of any business so acquired, and to exercise all the powers necessary or convenient in or about the conduct and management of such business.

To enter into, make, and perform contracts of every kind with any person, firm, association, or corporation, municipality, public body, county, territory, state, government, or colony, or a dependency thereof, and without limit as to the amount, to draw, make, accept, endorse, discount, execute, and issue promissory notes, draft, bills of exchange, warrants, bonds, debentures, and other negotiable and transferable instruments and evidence of indebtedness whether secured by mortgage, or otherwise, as well as to secure the same by mortgage or otherwise as may be permitted by the laws of the State of Idaho.

To have offices, conduct its business, and promote its objectives within or without the State of Idaho, in other states, the District of Columbia, the territories and colonies of the United States and in foreign countries without restriction as to place or amount.

To do any or all of things herein set forth to the same extent as natural persons might or could do in any part of the world as principals, agents, contractors, trustees, or otherwise, and either alone or in the company of others.

In general, to carry on any other business in connection therewith whether manufacturing, production, promotion, advertizing, selling, broadcasting, contracting, or advising not forbidden by the State laws of the State of Idaho, and with all the powers conferred upon corporations by the law.

### ARTICLE V


