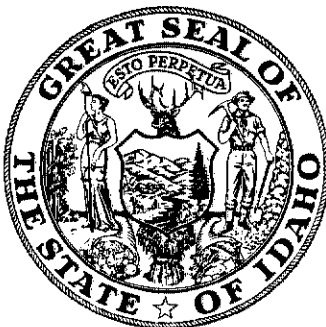

DURATION

This corporation shall have perpetual existence.

The number of directors may be increased or decreased from time to time by amendment to the Bylaws.

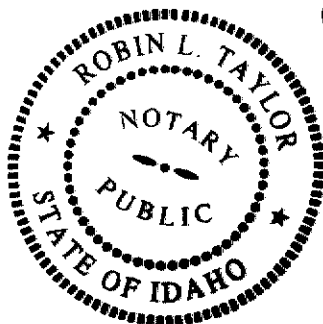
