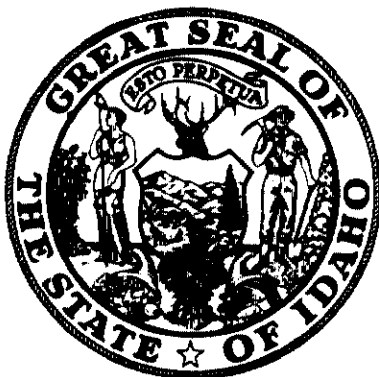

ARTICLES OF INCORPORATION

The undersigned incorporators, desiring to form a corporation pursuant to the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE. The name of the corporation is Perry's Inc.

ARTICLE TWO. The purpose of the corporation is to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE. The period of duration of the corporation is perpetual.

ARTICLE FOUR. The address of the corporation's initial registered office in the State of Idaho is 1732 Nixon Avenue, City of Nampa, County of Canyon, 83651. The name of the corporation's initial registered agent at such address is Blythe E. Perry.

ARTICLE FIVE. The total authorized number of shares is 1000, which shares are no par.

ARTICLE SIX. There are no special provisions denying preemptive rights and shareholder preemptive rights shall be determined in accordance with Section 30-1-26, Idaho Code.

ARTICLE SEVEN. To the extent permitted by law, the Corporation is authorized to repurchase its own shares and, when so doing, may utilize both unreserved and unrestricted earned surplus and unreserved and unrestricted capital surplus and

common and preferred capital and paid in capital.
