**CERTIFICATE OF AMENDMENT OF
ARTICLES OF INCORPORATION**

I, JAS. H. YOUNG, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

CHURCH OF CHRIST OF PAYETTE, IDAHO

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **29th** day of **August** 19 **58**, original articles of amendment, as provided by Sections **30-146, 30-147, 30-1104 & 30-1105, Idaho Code**, changing corporate name to: **FIRST CHRISTIAN CHURCH OF PAYETTE, IDAHO, INC.**, making corporation existence perpetual and restating Articles,

and that the said articles of amendment contain the statement of facts required by law, and are recorded on Film No. **103** of Record of Domestic Corporations of the State of Idaho.

I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have been amended accordingly.

ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
CHURCH OF CHRIST OF PAYETTE, IDAHO.

BE IT REMEMBERED, That a special meeting of the members of the Church of Christ of Payette, Idaho, legally held for such purpose at the Church of said corporation, located at Second Avenue North and 9th Street in the City of Payette, Idaho, on the 13th day of May, 1956, at 12:05 o'clock P.M., the Articles of Incorporation of the Church of Christ of Payette, Idaho, were amended as follows:

ARTICLE I

This corporation shall be designated and known as the FIRST CHRISTIAN CHURCH of Payette, Idaho, Inc.

ARTICLE II

That the principal place of business transactions of this corporation shall be in the City of Payette, in the County of Payette, and the State of Idaho.

ARTICLE IV

That the term for which this organization shall exist shall be perpetual.

ARTICLE V

This corporation shall consist of baptized believers in Christ Jesus, and membership in the said Church constitutes membership in the corporation, provided that only such members shall be members of the corporation who are of lawful age and provided that termination of membership in the Church shall terminate membership in the corporation. Voting privileges shall be accorded to all members who have shown an active interest through a recent continuity of attendance, service or giving.

ARTICLE VIII

If said Church shall fail to hold regular meetings for the full period of

ARTICLE IX.

The estimated value of the property of the corporation at this time is the sum of \$30,000.00.

ARTICLE X.

Amendments to these Articles may be made at any annual meeting of the members of this corporation or at a special meeting called for the purpose, three-fourths of the members present voting on the amendment provided that written notice of the proposed amendment has been given to the members of the congregation, and the proposed amendment has been read at a regular Sunday service at least two weeks before the vote is taken.

We, Lowell Coffey and Jesse A. Smith, hereby certify as follows:

That we are the Chairman and Secretary, respectively, of Church of Christ of Payette, Idaho; that in pursuance of direction of the Board of Elders assembled for the purpose of calling a membership meeting of the corporation, the Chairman and Secretary gave due legal notice of the holding of a special meeting of the membership on the 13th day of May, 1956, at 12:05 o'clock P.M., at the Church of said Corporation located at Second Avenue North and 9th Street in the City of Payette, Idaho, for the purpose of considering the amendment of the Articles of Incorporation of said corporation so as to make perpetual its period of corporate existence, and other amendments as therein set out; that the directing of such notice for such membership meeting by said Elders was upon the unanimous approval of all of the Elders, for such time and place and for the considering of the amendments to said Articles of Incorporation.

That pursuant to the direction of said Elders such membership meeting was

NOTICE IS HEREBY GIVEN That/a meeting of the Board of Elders of the Church of Christ of Payette, Idaho, held on the 5th day of April, 1956, at the office of said Church, in Payette, Idaho, it was ordered that a meeting of the members of said Church be called expressly for considering the subject of extension of the corporate existence of said Church to make same perpetual, and also to amend the Articles of Incorporation in certain particulars as follows: That Article I should be amended changing the name of the corporation to "First Christian Church of Payette, Idaho"; that Article V be amended by adding thereto the following "Voting privileges shall be accorded to all members who have shown an active interest through a recent continuity of attendance, serving or giving."; that Article VIII be amended by changing the words "Idaho Christian Convention" to "South Idaho-Utah Christian Missionary Convention"; that Article IX be amended by changing the figure "\$2000.00" to "\$30,000.00"; that Article X be amended to provide that amendments to Articles may be made by three-fourths of the members present voting on amendments, provided that written notice of amendment has been given to members of the congregation, according to law, and the proposed amendment has been read at a regular Sunday service at least two weeks before the vote is taken; said proposed amendments being approved by such Elders in said meeting;

And that the meeting so ordered by said Elders has been fixed as the 13th day of May, 1956, at 12:05 o'clock P.M., at the Church of said Corporation, located at Second Avenue North and 9th Street in the City of Payette, Idaho, at which time and place vote will be had upon the above propositions.

That pursuant to said notice, said meeting of membership of said corporation was held at the time and place specified in said notice; that at said meeting more than three-fourths of the members of the corporation qualified to vote were present in person or by proxy; that at said meeting the following resolution was

that date is necessary to the welfare of the membership; and

"WHEREAS, the name of the corporation should be changed from "Church of Christ, Payette, Idaho," to "First Christian Church of Payette, Idaho, Inc."; and

"WHEREAS, the location of the place of business of the corporation should be changed from Canyon County, Idaho, to Payette County, Idaho; and

"WHEREAS, the voting privileges on all matters pertaining to the corporation should be accorded to all members who have shown an active interest through a recent continuity of attendance, service or giving; and

"WHEREAS, the effects and business of the corporation, in the event said corporation shall fail to hold regular meetings for a full period of one year should go to South Idaho-Utah Christian Missionary Convention; and

"WHEREAS, the estimated property value of the corporation is now determined to be \$30,000.00; and

"WHEREAS, the number of members present and voting on amendments to Articles of Incorporation should be changed to three-fourths of the membership present voting on such an amendment, provided that written notice of the proposed amendment has been given to the members of the congregation and such proposed amendment read at a regular Sunday service at least two weeks before the vote is taken.

"NOW, THEREFORE, BE IT RESOLVED That the Articles of Incorporation of the corporation be amended as above set out; and

"BE IT FURTHER RESOLVED That the Chairman and Secretary of the Board of Elders of this corporation be, and they are hereby, authorized and directed to take such action, sign such documents and do all things necessary in the premises.

"BE IT FURTHER RESOLVED That the Articles of Incorporation be, and the same are hereby, amended to read as follows:

ARTICLE I

This corporation shall be designated and known as the FIRST CHRISTIAN CHURCH of Payette, Idaho, Inc.

ARTICLE II

That the principal place of business transactions of this corporation shall be in the City of Payette, in the County of Payette, and the State of Idaho.

ARTICLE IV

That the term for which this organization shall exist shall be perpetual.

ARTICLE VIII

If said Church shall fail to hold regular meetings for the full period of one year, then the effects and business of the corporation shall divert to South Idaho-Utah Christian Missionary Convention.

ARTICLE IX

The estimated value of the property of the corporation at this time is the sum of \$30,000.00.

ARTICLE X.

Amendments to these Articles may be made at any annual meeting of the members of this corporation or at a special meeting called for the purpose, three-fourths of the members present voting on the amendment provided that written notice of the proposed amendment has been given to the members of the congregation, and the proposed amendment has been read at a regular Sunday service at least two weeks before the vote is taken."

That said Resolution was read at length, thoroughly discussed, and its adoption was moved and seconded, and it was adopted by the affirmative vote of more than three-fourths of the members of the corporation and entered on the minutes of said meeting.
