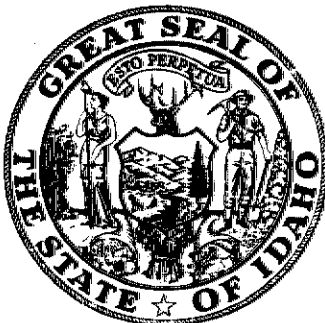

**ARTICLES OF INCORPORATION  
OF  
TRAIL BLAZER TRANSPORT, INC.**

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following articles of incorporation:

**ARTICLE ONE**

**Name.** The name of the corporation is **TRAIL BLAZER TRANSPORT, INC.**

**ARTICLE TWO**

**Duration.** The period of duration of the corporation is perpetual.

**ARTICLE THREE**

**Purposes.** The purposes of the corporation are to carry freight for hire, to receive and load all varieties of commercial freight on board highway motor vehicles; to transport freight in both inter and intrastate commerce throughout the United States and to buy, sell, lease, and otherwise deal in and with tractors and trailers suitable for commercial trucking, and to maintain and repair the same; and to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

**Stock and Par Value.** The aggregate number of shares which the corporation shall have authority to issue, which shall consist of one class only, shall be one thousand (1000) shares, the par value of each of such shares shall be One Hundred Dollars (\$100.00).

#### ARTICLE FIVE
