

GREGORY INVESTMENTS PARTNERSHIP AGREEMENT

AND

CERTIFICATE OF LIMITED PARTNERSHIP

THIS AGREEMENT AND CERTIFICATE OF LIMITED PARTNERSHIP is made between the undersigned parties on the date of certification set forth below. This document shall constitute not only the agreement between the parties, but shall also constitute a Certificate of Limited Partnership and the General Partners shall file this document in the office of the County Recorder which is the location of the principal place of partnership business, in accordance with I.C.A. 63.202.

1. FORMATION OF LIMITED PARTNERSHIP. ROGER G. GREGORY and ANNIE GREGORY, as the General Partners; ROGER G. GREGORY, ANNIE GREGORY, and ROGER G. GREGORY as custodian for CHANTAL M. GREGORY, MICHELE A. GREGORY and CHRISTINE R. GREGORY under the Idaho Uniform Gifts to Minors Act, as the Limited Partners, hereby agree to form a Limited Partnership pursuant to I.C.A. 53.301 commonly referred to as the Uniform Limited Partnership Law of the State of Idaho, upon the terms and conditions contained in this Agreement and Certificate of Limited Partnership.

The General Partners shall forthwith notify the bank, principal customers and creditors of the existence of the Partnership and its members. The General Partners shall cause all insurance policies, leases and other business contracts to be changed to reflect the existence of the Partnership.

2. NAME AND PLACE OF BUSINESS. The name of the Limited Partnership shall be the GREGORY INVESTMENTS, an Idaho Limited Partnership (the Partnership). The principal place of business of the Partnership shall be Box 699, Priest River, Idaho, or at such other place or places as the General Partners may hereafter determine. The General Partners shall give notice to the Limited Partners, if any, promptly after any change in the location of the principal place of business or office of the Partnership.

Agreement, binding on all the parties hereto, notwithstanding that all of the parties are not signatory to the original or the same counterpart.

34. ENTIRE AGREEMENT. This Agreement contains the entire understanding between the General Partners and Limited Partners and supercedes any prior written or oral agreements between them respecting the within subject matter. There are no representations, agreements, arrangements or understandings, oral or written, between and among the Partners hereto relating to the subject matter of this Agreement which are not fully expressed herein.

35. PARTITION. Each of the Limited Partners hereby irrevocably waives any and all rights that he may have to bring an action for partition with respect to his undivided interest in the Partnership property under the laws now existing or hereafter enacted.
