SECOND: The period of its duration is perpetual.

8 be incorporated under the Idaho Business Corporation Act.

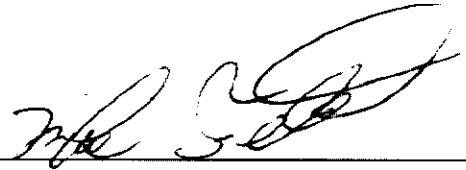

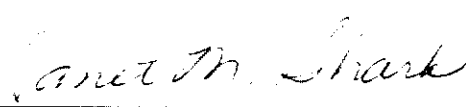
