

CERTIFICATE OF OWNERSHIP AND MERGER

MERGING

THEATRE EQUIPMENT CONTRACTS CORPORATION

NATIONAL THEATRE SUPPLY COMPANY, a corporation organized and existing under the laws of Delaware,

DOES HEREBY CERTIFY:

FIRST: That this corporation was incorporated on the 3rd day of September, 1926, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That this corporation owns all of the outstanding shares of each class of the stock of Theatre Equipment Contracts Corporation, a corporation incorporated on the 24th day of August, 1927, pursuant to the General Corporation law of the State of Delaware.

THIRD: That this corporation, by the following resolutions of its Board of Directors, duly adopted at a meeting held on the 27th day of September, 1968, determined to and did merge into itself said Theatre Equipment Contracts Corporation:

RESOLVED that National Theatre Supply Company merge, and it hereby does merge into itself said Theatre Equipment Contracts Corporation, and assumes all of its obligation.

FURTHER RESOLVED that the merger shall be effective upon the date of filing with the Secretary of State of Delaware.

FURTHER RESOLVED that the proper officers of this corporation be, and they hereby are, directed to make and execute, under the corporate seal of this corporation, a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge said Theatre Equipment Contracts Corporation and assume its liabilities and obligations, and the date of adoption thereof, and to cause the same to be filed with the Secretary of State and a certified copy in the office of the Recorder of Deeds of New Castle County and to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in anywise necessary or proper to effect said merger.
