Pursuant to the provisions of § 30-1-1007 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Restated Articles of Incorporation:

ARTICLE 1. Name. The name of the corporation is SV Rides Ltd.

ARTICLE 2. Shares. The corporation is authorized to issue 10,000 shares, all of one class.

ARTICLE 3. Registered Office and Registered Agent. The address of the corporation's initial registered office in the state of Idaho is 108 West 100 South, Rexburg, Idaho 83440. The name of the corporation's registered agent at such address is Steven J. Hart.

ARTICLE 4. Directors. The Board of Directors shall consist of one or more directors. The number of directors constituting the current Board of Directors is two and the names and addresses of the persons who are to serve as directors until the next annual meeting of the shareholders or until their successors are elected and qualified are:

ARTICLE 5. Limitation on Personal Liability of Directors. No director of the corporation shall be personally liable to the corporation or its shareholders for money damages for any action taken, or any failure to take any action, as a director, except liability for:

- (i) The amount of a financial benefit received by a director to which he is not entitled,
- (ii) An intentional infliction of harm on the corporation or the shareholders,
- (iii) A violation of section 30-1-833, Idaho Code, or

- (iv) An intentional violation of criminal law.

ARTICLE 6. Indemnification. The corporation shall indemnify the directors and officers of the corporation to the fullest extent permitted by the Idaho Business Corporation Act, as the same exists or may hereafter be amended (but, in the case of any such amendment, only to the extent that such amendment permits the corporation to provide broader indemnification rights than the Idaho Business Corporation Act permitted the corporation to provide prior to such amendment).
