Pursuant to due notice given in writing to the membership of Ada County Association for Retarded Children, Inc. at the regular meeting of the membership, at which a quorum was present, held at 14102 Albion street, Boise City, Ada County, Idaho at 8:00 P.M. April 16th. 1974 as provided in the Constitution and Bylaws of the Association, a resolution was presented to amend the arcticles of Incorporation of the Association as follows:

> " Amend Arcticle I, the name, by striking out the word Children and replacing it with the word Citisens." Also that where the word "Children" appears in the NAME in the Constitution and Bylaws of the Association it shall be changed to "Citizens". There by changing the name to Ada County Association for Retarded Citizens, Inc.
