ARTICLES OF INCORPORATION
OF
CREDIT BUREAU OF LEMHI COUNTY, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, citizens of the United States of America, and residents of the State of Idaho, over the age of 21 years, do hereby voluntarily associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby make, sign, acknowledge and file this Certificate for that purpose, as follows:

ARTICLE I.

The name of this corporation is and shall be "CREDIT BUREAU OF LEMHI COUNTY, INC."

ARTICLE II.

The existence of this corporation shall be perpetual.

ARTICLE III.

The principal business of this corporation is to be transacted at Salmon, Lemhi County, Idaho, hereby designated as its principal place of business and location and post office address of its registered office in the State of Idaho.

ARTICLE IV.

The purposes for which said corporation is formed are:

1. In accordance with the laws of the State of Idaho and/or any other state, to own and operate a credit bureau reporting and collection business, including but not limited to the business of a commercial collection agency, and otherwise to do all things necessary or incidental to, or in connection with the operation of such businesses.

2. To purchase or in anywise acquire for investment or for sale, or otherwise, lands, contracts for the purchase or

sale of lands, buildings, improvements, and any other real property of any kind or tenure, or any interest therein, and any property, works, or undertakings connected with the use or development of any property of the company within the State of Idaho, and within any other state or territory of the United States; and as the consideration for same, to pay cash or to issue the capital stock, debenture bonds, mortgage bonds, or other obligations of the company, and to sell, convey, lease, mortgage, turn to account, or otherwise deal with all or any part of the property of the company.

ARTICLE V.

To engage in any commercial, industrial or other business of any kind or nature calculated or designed to be profitable to this corporation, and in conformity with the laws of the State of Idaho;

To generally engage in, do and perform, any enterprise, act or vocation that a natural person might, or could do or perform;

ARTICLE VI.

To subscribe for, acquire by purchase or otherwise, and to own, hold, sell, assign and transfer shares of the capital stock of any other corporation, and to exercise all the rights of a stockholder; to acquire by purchase or otherwise, hold and dispose of the stock of this corporation.

ARTICLE VII.

From time to time to apply for, purchase, or acquire by assignment, transfer or otherwise, and to exercise, carry out and enjoy any license, power, authority, franchise, concession, right or privilege which any government or authority, or other public body may be empowered to enact, make or grant.

ARTICLE VIII.

The governing body of the corporation shall be a board of directors, and the number of the directors on said board shall be that specified in the by-laws, but shall in no event be less than three.

ARTICLE IX.

The board of directors of this corporation may meet and transact the business of this corporation either at the principal place of business herein designated, or at such other place within or without the State of Idaho as may be designated by resolution of the board of directors.

ARTICLE X.

The amount of the total authorized capital stock of this corporation is 50 shares without nominal or par value, and it shall be all of the same class. Such stock may be issued from time to time without action by the stockholders for such consideration as may be fixed from time to time by the board of directors, and shares so issued, the full consideration of which has been paid or delivered, shall be deemed fully paid stock, and the holder of such shares shall not be liable for any further payment thereon.

ARTICLE XI.
