#### ARTICLES OF INCORPORATION

OF

SPORTS XPRESSIONS, INC.

We, The undersigned natural persons, over the age of eighteen years, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following artilees of Incorporation for such Corporation:

#### ARTICLE I

NAME

The name of the corporation is SPORTS XPRESSIONS, INC.

ARTICLE II

DURATION

The period of its duration is perpetual.

#### ARTICLE III

## PURPOSES

The purpose for which the corporation is organized are: To generally operate a skating and athletic instruction business and to render any services necessary in the judgement of the officers of this corporation, to conduct the said business.

To own, purchase, sell, lease or otherwise deal in real and personal property of any nature whatsoever, whenever located in conjuction and the operation of said business.

To lease, buy, seil, use, mortage, improve and otherwise deal in all types of property, real and personal, as may be necessary or appropriate in connection with the business of the corporation, including, but not limited to, becoming a partner or joint adventurer in undertakings of all types.

In addition to the foregoing purposes, the corporation may also engage in any and all other lawful acts, that presently or in the future, may leaglly be preformed by a corporation organized under the laws of the State of Idaho.

## ARTICLE IV

## AUTHORIZED SHARES.

The number of the shares that the corporation shall have the authority to issue is 1000 shares, with no par value. These shares will be known as Common Stock. All shares issued by the coporation shall be fully paid, nonassessable and shall have equal rights.

#### ARTICLE V

### RIGHT TO PURCHASE SHARES

The corporation shall have the right to purchase its own shares to the extent of its unreserved and unrestricted earned surplus and also to the extent of its unreserved and unrestricted capital surplus in accordance with a resolution adopted by its Board of Directors.

The Board of Directors of the corporation may designate such committee or committees as it determines in accordance with the law to exercise such authority as the Board of Directors shall delegate in the resolution designating such committee or comittees.

#### ARTICLE VI

## REGISTERED OFFICE AND AGENT

### ARTICLE VII

## PREEMPTIVE RIGHTS

The shareholders shall have the preemptive rights to acquire additional securities. The Corporation shall also have all powers enumerated under the general business corporation laws of the State of Idahoand those set forth in its Bylaws.

#### ARTICLE VIII

#### DIRECTORS

The corporation shall have a minimum of three (3) directors as shall be set forth in the By-Laws of the corporation. Until their successors ar duly elected and qualified, the original directors shall be the following:
