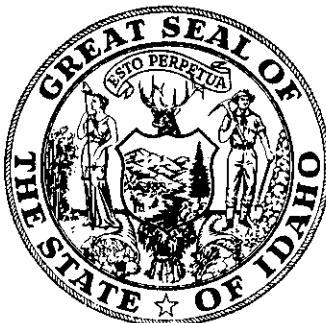

**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF**

LEFORGEE, ROGERS & EVANS, CHARTERED

Pursuant to the provisions of *Idaho Code* 30-1-59, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is *Leforgee, Rogers & Evans, Chartered*.

SECOND: Article I of the Articles of Incorporation is amended to read:

"The name of the corporation is *Leforgee, Rogers, Evans & Braga, Chartered*."

THIRD: This amendment was adopted by the shareholders of the corporation at a special meeting held on October 2, 1992.

FOURTH: The number of shares of the corporation outstanding at the time of such adoption was 80; and the number of shares entitled to vote thereon was the same. The corporation has only one class of stock.

FIFTH: The number of shares voted for the amendment was 80; and the number of shares voted against such amendment was 0.
