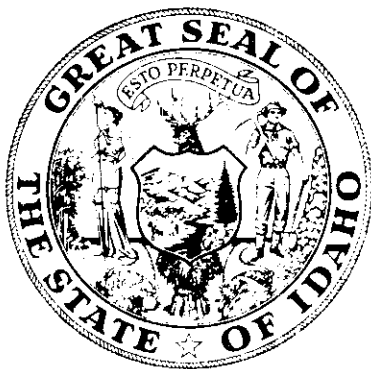

That pursuant to the provisions of the Idaho Code, Section 30-1-61, G. KENT TAYLOR, P.A. an Idaho Corporation, has changed its corporate name, and to that extent amends its Articles of Incorporation as follows:
