ARTICLES OF INCORPORATION SECRETARY OF STATE

OF

AHERIN, RICE & BROWN, P.A.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, DARREL W. AHERIN, STEPHEN C.

RICE, and CHARLES A. BROWN, who are over the age of majority, residents of the State of Idaho, and legally authorized to practice law in the State of Idaho, desiring to form a professional corporation in accordance with Title 30, Chapter 13 of the Idaho Code, do hereby associate themselves for the purpose of forming a professional corporation and adopt the following Articles of Incorporation, to-wit:

ARTICLE ONE

NAME

The name of the corporation shall be AHERIN, RICE & BROWN, P.A.

ARTICLE TWO

PURPOSES

The purposes for which the corporation is organized are as follows:

- (1) Primarily to engage in every phase and aspect of the practice of law under the laws of the State of Idaho;
- (2) To engage generally in the business of a law corporation as the same is now or hereinafter may be defined by statute, rule and regulation, and in connection therewith to own property, to enter into contracts, and to transact any lawful business related thereto;

(3) To engage in such other business as may be authorized or permitted by the laws of the State of Idaho governing professional corporations.

ARTICLE THREE

PRINCIPAL OFFICE

The place in the State of Idaho were the corporation's principal office is to be located is 1212 Idaho Street, City of Lewiston, County of Nez Perce.

ARTICLE FOUR

REGISTERED AGENT

The registered agent of the corporation found at the above address is STEPHEN C. RICE, J.D.

ARTICLE FIVE

DIRECTORS

The number of directors of the corporation shall be at least three (3), but no more than five (5). The names and addresses of the persons who are appointed to act as directors until the first annual meeting, or until their successors are duly chosen and qualified, are:

ARTICLE SIX

STOCK

The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares of common stock, each with the par value of \$1.00.

ARTICLE SEVEN

DURATION

The duration of this corporation shall be perpetual.

ARTICLE EIGHT

REGULATION OF INTERNAL AFFAIRS

Provisions for the regulation of the internal affairs of the corporation, including provisions restricting the transfer of shares are:

- 1) No shares of the capital stock of the corporation shall be issued to any one other than an individual who is legally authorized to render services as an attorney at law and a member of the bar in the State of Idaho.
- 2) No shareholder of this corporation shall sell or transfer any of his shares in the corporation except to another individual who is eligible to be a shareholder of this corporation and then only in accordance with procedures set forth in the By-Laws of the corporation for such sale or transfer. Any shares transferred to any person or entity ineligible to be a shareholder, whether such transfer be voluntary, involuntary or by operation of law, shall be redeemed or canceled by this corporation.
- 3) No shareholder of this corporation shall enter into any voting trust agreement or other type of agreement vesting another person with the authority to exercise the voting power of any or all of his stock.

If directors, officers or shareholders of this corporation become legally disqualified to render services as an attorney at law in the State of Idaho, he shall immediately sever all employment with and financial interest, other than interest as a creditor, if any, in this corporation.

ARTICLE NINE

BY-LAWS

The Board of Directors of this corporation shall have the power to adopt, alter, amend or repeal the By-Laws of the corporation.

ARTICLE TEN

PAYMENT FOR SHARES

Any shareholder shall have the right to dissent and obtain payment for shares under Idaho Code Section 30-1-80 in the event the shareholders or corporation cannot agree with an individual shareholder as to the sale or redemption of his shares, so long as such action is not in conflict with the By-Laws or any buy-sell agreement between the shareholders pertaining to the sale or redemption of a shareholder's shares.
