

Designation of Agent, and Acceptance of the Provisions of the Constitution of the State of Idaho.

KNOW ALL MEN BY THESE PRESENTS:

That Spokane Mining & Milling Company
a Corporation organized and existing under the laws of the State of Washington
having filed in the office of the Secretary of State of the State of Idaho a duly authenticated copy
of its Articles of Incorporation, does hereby, in pursuance of the laws of the State of Idaho, make

hereby accept the provisions of the Constitution of the State of Idaho for all the intents and pur-
poses contemplated by the provisions thereof, relating to such acceptance by other than municipal
corporations. (Article XI, Section 7, Constitution of Idaho.)
