



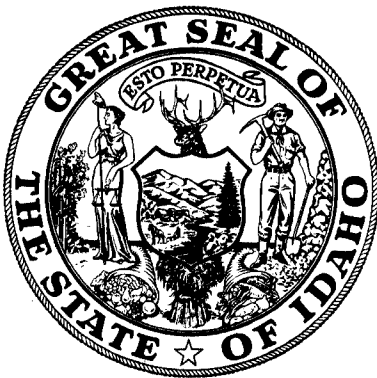
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

The undersigned hereby states the following to form a corporation under the laws of the State of Idaho.

I. NAME

The name of the corporation is KUFTAR, INC.

II. PERIOD OF DURATION

The corporation shall have perpetual duration.

III. PURPOSES

The purpose of the corporation is the transaction of all lawful business.

IV. AUTHORIZED SHARES

The corporation shall have the authority to issue Fifty Thousand (50,000) shares of its common stock with a par value of One Dollar (\$1.00) each. Such stock shall not be assessable for any purpose.

V. REGISTERED OFFICE AND AGENT

The address of the registered office of the corporation is 1312 Eastman, Boise, ID 83702.

The name of the registered agent of the corporation is Iver J. Longeteig, 1312 Eastman, Boise, ID 83702.

VI. BOARD OF DIRECTORS

The initial board of directors shall number one, whose name and address is:

The initial board of directors shall serve until the first annual meeting of shareholders or until their successors are elected and qualified.

VII. REDEMPTION

The corporation shall have the right to purchase, redeem, take, receive or otherwise acquire, hold, own, pledge, transfer or otherwise dispose of its own shares, and purchases of redemptions of its own shares, whether direct or indirect, may be made to the extent of unreserved and unrestricted capital surplus available therefor.

VIII. DISTRIBUTION FROM CAPITAL SURPLUS

When and as determined by the Board of Directors, the Corporation may, from time to time, distribute to its shareholders out of capital surplus of the corporation a portion of its assets in cash or property.
