The undersigned, acting as incorporator of a corporation under the Idaho Professional Service Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. NAME: The name of the corporation is BLAKE D. ALEXANDER, M.D., P.A.

2. <u>**DURATION**</u>: The period of its duration is perpetual.

3. **PROFIT:** This is a for profit corporation.

4. <u>PURPOSES</u>: The purpose or purposes for which the corporation is organized is to engage in the practice of dermatology and do all things incidental thereto and for the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Professional Service Corporation Act, as the same from time to time shall be amended.

9. **BOARD OF DIRECTORS:** There shall be no Board of Directors. Pursuant to Idaho Code § 30-1-732, the powers and duties conferred or imposed upon the Board of Directors by
