ARTICLES OF INCORPORATION

OF

CROOT PLUMBING AND HEATING COMPANY

an Idaho Corporation

We, the undersigned, all being of legal age and citizens of the United States, State of Idaho, acting as incorporators of a corporation under the laws of the State of Idaho, do adopt the following articles of incorporation for such corporation.

The name of this corporation shall be:

The principal place of business of the Corporation shall be Coeur d'Alene, Kootenai County, Idaho.

Ш

The duration of this corporation shall be for a period of Fifty (50) years.

IV

The location of this corporation shall be, and the Post Office Address and registered office in the State of Idaho, is:

V

The purposes or purpose for which this corporation is organized are:

To install and repair heating plants, gas fittings and apparatus in buildings, and to do a general plumbing business. To engage in the buying and selling and manufacturing of plumbing and heating supplies of every kind, nature, and description, both domestic and industrial, and in the buying and selling of all building supplies and equipment of any kind, nature or description whatsoever. To manufacture, experiment, invent, develop, improve, purchase, sell, and generally deal in plumbers' and heaters' supplies, fixtures, tools, appliances, sanitary fixtures, and any and every kind of wares, articles, and merchandise which are or may be used by plumbers, and to carry on the business of inventors, manufacturers, wholesalers, retailers, importers, and exporters in plumbing fixtures and supplies, and any and all kinds of wares and merchandise. To experiment, invent, patent, manufacture and generally deal in and with chemicals, chemical compounds, chemical preparations, secret processes and mixtures of any and all kinds to be used in the plumbing or any other kind of business.
