PLAN OF MERGER (the "Plan") dated this 27th day of August 2014, pursuant to the laws of the State of Idaho and the State of California, between WIGU Publishing, LLC, a California limited liability company, with offices at 321 Third Street, Laguna Beach, CA 92651 (the "Disappearing LLC") and WIGU Publishing, LLC, an Idaho limited liability company, with offices at 220 Second Avenue, Suite 102, Ketchum, ID 83340 (the "Surviving LLC").

WHEREAS, the Disappearing LLC and the Surviving LLC wish to merge, with the Disappearing LLC merging into the Surviving LLC.

NOW, THEREFORE, the parties to this Plan, in consideration of the mutual covenants, Plans and provisions hereof, hereby agree to the terms of this merger, as follows:

FIRST: WIGU Publishing, LLC, a California LLC, hereby merges itself into WIGU Publishing, LLC, an Idaho limited liability company, and such Idaho limited company shall be the surviving limited liability company.

SECOND: The Certificate of Organization and the Operating Plan of WIGU Publishing, LLC, an Idaho limited liability company, shall remain in full force and effect and this entity shall be the surviving business entity, as that term is defined under the applicable laws of the State of Idaho, and WIGU Publishing, LLC, A California limited liability company shall be dissolved and shall disappear, as provided under the applicable laws of the State of California.

THIRD: Barron E. Ressler, the Trustee of a Trust established 3/24/92, sole member of WIGU Publishing, LLC, an Idaho limited liability company, shall remain as the sole member and/or manager of such Idaho entity, following the merger.

FOURTH: All of the outstanding Membership Interests in the Disappearing LLC shall be cancelled without consideration, and all of the outstanding Membership Interests of the Surviving LLC shall remain outstanding and shall not be affected by this merger.

FIFTH: Upon the merger becoming effective, all of the property, rights, privileges, copyrights, contracts, patents, trademarks, licenses, registrations and other assets of each and every kind and description, of the Disappearing LLC shall be transferred to, vested in, and devolve upon the Surviving LLC, without further act or deed, and all property, rights, and every other interest of the Disappearing LLC and of the Surviving LLC shall be effectively the property of the Surviving LLC, as they were the property of the Disappearing LLC and the Surviving LLC, respectively, prior to the merger.

SIXTH: The Disappearing LLC shall, from time to time, if and when requested by the Surviving LLC, execute and deliver to the Surviving LLC all assignments, documents

and instruments, and to take all such action that shall be necessary or desirable, to carry out the terms of this merger and the intent of the parties.

SEVENTH: The effective date of this merger, shall be the date that this Plan is filed with the Secretary of State of the State of Idaho, or, as otherwise prescribed by law.

EIGHTH: This Plan may be amended, terminated, or abandoned by the authorized representatives of both of the parties, prior to the time that this Plan, as filed with the Secretaries of State of Idaho and California shall become effective.

NINTH: The merger was approved by all of the Members of the Disappearing LLC and all of the Members of the Surviving LLC.

TENTH: This Plan of Merger shall be filed with the Secretary of State of California and with the Secretary of State of Idaho in lieu of a Statement of Merger, in accordance with Title 30, Chapter 18, Part 2, Section 30-18-205 (5) of the Idaho Code.

IN WITNESS WHEREOF, the parties to this Plan, pursuant to approvals and authority given by resolutions by the members or managers of the parties, have caused this Plan to be executed as the deed of said entities, on the date first written above.
