**ARTICLES OF INCORPORATION**

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

**I**

The name of the corporation shall be Hartsook Corporation.

**II**

The corporation shall exist in perpetuity.

**III**

The address of the initial registered office of this corporation in the state of Idaho shall be 1920 N. Todd Way; Meridian, Idaho 83642, and the name of the initial registered agent at that address shall be Howard Hartsook.

**IV**

The purposes for which this corporation is organized shall be and are:

- (1) To engage in the operation of retail beverage and food establishments.
- (2) To purchase, sell, lease or otherwise acquire, own, hold, improve, use and otherwise deal in and with real and personal property, or any interest therein.



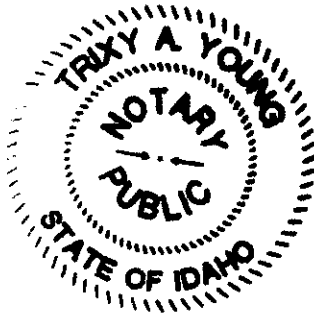


