ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF ASSOCIATION OF ZIONS FIRST NATIONAL BANK

(Hereafter ZB, National Association)

Pursuant to 12 U.S.C. 21a, Zions First National Bank does hereby certify that:

FIRST: The title of the Association is Zions First National Bank.

SECOND: That paragraph <u>FIRST</u> of the Amended and Restated Articles of Association of the Association is amended and replaced in its entirety with the following:

"FIRST. The title of this Association shall be ZB, National Association."

THIRD: A majority of the Association's shareholders approved the change of the name of the Association by written consent on July 16, 2015.
