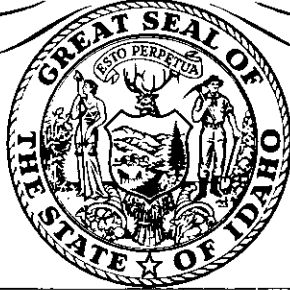

ARTICLES OF INCORPORATION

OF

IDAHO AIR TANKERS, INC.

We, the undersigned, natural persons of the age of twenty-one years or more, being citizens of the United States, acting as incorporators, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is IDAHO AIR TANKERS, INC., and its duration shall be perpetual.

ARTICLE II

The purposes for which the corporation is organized are:

(a) To engage in the operation of airplanes of different designs and capacity in fire suppression work for the Forestry Service of the United States of America;

(b) To engage in the hauling of products, goods and materials of various sorts from various points in the United States or outside of the United States to other points inside of the United States;

(c) To purchase, hold and own tools and equipment related to the foregoing business and to acquire, hold, improve, sell, convey, mortgage, lease, sublet and deal in real and personal property;

(d) To purchase equipment in connection with the acquisition, holding, improvement and ownership of realty, either improved or unimproved;

(e) To enter into leases and lease agreements of personal property;

(f) To participate with other persons, partnerships or corporations in joint ventures, work and profit-sharing agree-

ments and other combinations for the performance of contracts, business or activity in which the corporation might engage; and

(g) To execute and be bound by joint and several notes and other obligations and evidences of indebtedness with any individual, partnership or other corporation; to endorse, guarantee and secure the payment of the notes, bonds, debentures, obligations and evidences of indebtedness of any individual, partnership or other corporation, and to mortgage, pledge or hypothecate any assets of this corporation in connection with any such joint and several notes, obligations or evidences of indebtedness of any such endorsement or guarantee.

ARTICLE III

The location and post office address of the registered office of this corporation shall be 616 State Street, Boise, Ada County, Idaho.

ARTICLE IV

The total authorized number of shares shall be three hundred (300) shares of common capital stock of the par value of Ten Dollars (\$10.00) per share, said stock to be voting stock.
