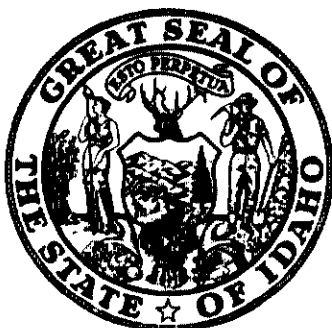

PURSUANT TO the provisions of Section 30-327 of the Idaho Code, the undersigned Corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: The name of the Corporation is PRATT RANCH, INC.

SECOND: The following amendment of the articles of incorporation was adopted by the members of the Corporation on January 23, 1993 in the manner prescribed by the Idaho Nonprofit Corporation Act:

Article I of the Articles of Incorporation is amended in its entirety to read as follows:
