ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION Of JAYKER TREE FARM, INC.

Pursuant to the provisions of § 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Article of Amendment to its Articles of Incorporation:

The name of the corporation is Jayker Tree FIRST: Farm, Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on January II, 1990, in the manner prescribed by the Idaho Business Corporation Act:

ARTICLE IV AUTHORIZED CAPITAL

The authorized capital of this total corporation shall be One Million and No/100 Dollars (\$1,000,000.00) and the total authorized number of shares shall be One Million shares of the par value of One and No/100 Dollars (\$1.00) per share.

The number of shares of the corporation THIRD: outstanding at the time of such adoption was 300,000. The number of shares entitled to vote thereon was 300,000.

FOURTH: The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:
