#### ARTICLE ONE

The name of the corporation is TRAIL RIDGE HOMEOWNERS ASSOCIATION, INC., hereinafter called the "Association".

#### ARTICLE TWO

#### ARTICLE THREE

#### ARTICLE FOUR

#### PURPOSE AND POWERS OF THE ASSOCIATION

This Association does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which it is formed are to provide for maintenance, preservation and architectural control of the residence Lots and Common Area within that certain tract of property located in Canyon County, Idaho, and to promote the health, safety and welfare of the residents within the above described property and any additions thereto as may thereafter be brought within the jurisdiction of this Association for the purpose to:

(a) exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in that certain Declaration of Covenants, Conditions and Restrictions,

hereinafter called the "Declaration", applicable to the property and recorded or to be recorded in the records of Canyon County, Idaho, and as the same may be amended from time to time as therein provided, said Declaration being incorporated herein as if set forth at length;

- (b) fix, levy, collect and enforce payment by any lawful means, all charges or assessments pursuant to the terms of the Declaration; to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Association, including all licenses, taxes or governmental charges levied or imposed against the property of the Association;
- (c) acquire (by gift, purchase or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Association;
- (d) borrow money, and as provided in the Declaration, mortgage, pledge, secure or hypothecate any or all of its real or personal property as secured for money borrowed or debts incurred;
- (e) dedicate, sell or transfer all or any part of the common area to any public agency, authority or utility for such purposes and subject to such conditions as may be agreed to by the members as set forth in the Declaration;
- (f) participate in mergers and consolidations with other nonprofit corporations organized for the same purposes or annex additional residential property and common area, as provided in the Declaration;
- (g) have and to exercise any and all powers, rights and privileges which a corporation organized under the Non-Profit Corporation law of the State of Idaho by law may now or hereafter have or exercise.

#### ARTICLE FIVE

### **MEMBERSHIP**

Every person or entity who is a record owner of a fee or undivided fee interest in the following described real property shall be a member of the association:

A lot in TRAIL RIDGE ESTATES, City of Parma, Canyon County, Idaho, according to the Plat thereof filed in the office of the County Recorder, Canyon County, Idaho.

The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation.

### ARTICLE SIX

## **VOTING RIGHTS**

The Association shall have two classes of voting membership:

<u>Class A.</u> Class A members shall be all Owners of Lots designated for residential purposes and shall be entitled to one vote for each Lot owned.

Class B. The Class B member shall be the developer, its successors and assigns, who shall have one vote. The Class B membership shall cease upon written notice to the Association no later than December 31, 2019.

When more than one person holds interest or interests in any Lot or Living Unit the vote for such Lot or Living Unit shall be exercised as they among themselves determine.

# ARTICLE SEVEN

## **BOARD OF DIRECTORS**

The affairs of this Association shall be managed by a Board of Directors. The initial Board of Directors shall consist of four (4) directors, provided however, that the number of directors may be
