

CERTIFICATE OF INCREASE IN CAPITAL STOCK OF STATE BANK OF
COMMERCE.

THIS IS TO CERTIFY, that at a meeting, being the regular annual meeting, of the Stockholders of the State Bank of Commerce, a corporation organized and existing under the laws of the State of Idaho, held on the 28th day of April, A.D. 1906, at the office of the said corporation in the City of Wallace, County of Shoshone, and State of Idaho, there were present more than two-thirds of the entire capital stock of said corporation, to wit: 520 shares; and that then and there B.F.O'Neil was elected chairman, and E.S.Wyman was elected secretary of said stockholders' meeting; and it was thereupon by unanimous vote of all the stock present, to wit: 520 shares, RESOLVED, that the capital stock of said corporation be increased from sixty thousand dollars (\$60,000) divided into six hundred (600) shares, of the par value of one hundred dollars (\$100.) per share, to one hundred thousand dollars (\$100,000) divided into one thousand (1000) shares of the par value of one hundred dollars (\$100.) per share, according to the provisions of the Constitution and Laws of the State of Idaho.

IN WITNESS WHEREOF, the said B.F.O'Neil, Chairman, and E.S.Wyman, Secretary of said stockholders' meeting, and August Paulson, G.Scott Anderson, B.F.O'Neil, R.S.Wyman and Ewen McIntosh a majority of the directors of said corporation, have hereunto subscribed and signed their names, and caused the corporate seal of the said corporation to be hereunto affixed, this 31st day of December, A.D. 1906.
