



Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is McCluskey Foodservice, Inc., which is amended as hereinafter set forth.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on March 17, 1991, in the manner prescribed by the Idaho Business Corporation Act:

NAME

The corporate name McCluskey Foodservice, Inc., is amended to "Northwest Distribution Services, Inc.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 200 shares of common stock; and the number of shares entitled to vote thereon was 200.

FOURTH: The number of shares voted for such amendments was 200; and the number of shares voted against such amendment was 0.
