The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for this corporation.

I.

The name of this corporation shall be Stoneridge, Inc.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The address of the initial registered office of this corporation is 1088 N. Cole Road, Boise, Idaho, 83704, and the name of the initial registered agent at such address is Michael G. Matzek.

IV.

The nature of business and the object and purpose of this corporation shall be as follows:

Any part of the capital stock and any part of the notes, debentures, bonds, or other securities convertible into or carrying options or warranties to purchase stock of this corporation authorized by these Articles of Incorporation or by any amended articles duly filed, may at any time be issued, optioned for sale, and sold or disposed of by this corporation pursuant to a resolution of its Board of Directors to such persons and upon such terms as may to such Board seem proper without first offering such stock or securities of any part thereof to existing shareholders.
