## ARTICLES OF INCORPORATION OF COWBOYS, INC.

The undersigned, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following articles of incorporation.

ARTICLE ONE: Name. The name of the corporation is Cowboys, Inc.
