ARTICLES OF INCORPORATION

OF

STATE TRACTOR AND SUPPLY COMPANY, INC.

an Idaho Corporation

KN'W ALL TEN BY THESE PRESENTS:

That we, the undersigned HAR MLD LOUGH, D. I. HOOD, MARGUERITE HOOD, and HELENE LOUGH, being natural persons of full age, citizens of the United States and residents of the State of Idaho, in order to form a corporation for the purposes merein stated, pursuant to Chapter One (1) of Title Thirty (30) of the Idaho Code, do hereby certify as follows:

ARTICLE I

The name of this corporation shall be "STATE TRACTOR AND SUPPLY COMPANY, INC.".

ARTICLE II

The purposes for which said corporation is formed are to carry on the business of operating and managing, either as owner or lessee, a farm implement business including all related lines or activities therefor and including, but not limited to, the sale of parts for said farm and agricultural implements and the repair thereof and also including therewith the operation, either as owner or lessee, of a boat marina, including the sale of boats, notors and parts and the servicing thereof.

To purchase, lease and otherwise acquire property, real, personal and mixed, of every nature and location, both within and without the State of Idaho, and to hold, operate, develop, improve, lease, exchange, trade in, deal with, sell and alienate the same, in whole or in part, as freely and fully as any natural person may lawfully do.

To borrow money and contract indebtedness, and to evidence the indebtedness by notes, bonds or other instruments, and to secure the same by pledge, mortgage, trust, deed, or such other encumbrances $u_{\rm p}$ on its property as to the company may seem proper; to loan money and take any form of security for the payment of the same and to hold, operate, sell, encumber or otherwise

deal with such property as may be taken in security for or in payment of debts owing to the corporation.

To acquire and operate the business and goodwill of any other person or persons, firms and corporations transacting such business as this company may lawfully transact.

To acquire and own the stock, bonds and securities of other corporations and, while owning the same, to exercise all the privileges of ownership consistent with the corporate character of this company and to acquire the stock, common or preferred, of this corporation insofar as the same is not prohibited by the laws of the State of Idaho.

To make and perform contracts of every kind with any person, firm, association or corporation.

To do any and all things convenient and incidental to the purposes herein expressed and generally to have and exercise all such powers as are by law conferred on corporations of like character and, without in any particular limiting any of the objects or purposes or powers of the corporations, the business and purposes of the corporation shall be from time to time to do any one or more or all of the acts and things herein set forth and all such other acts, things and business in any manner connected therewith directly or indirectly to promote the interests of the corporation or enhance the value of any of its property as such corporation may lawfully do and, in carrying on its business or for the purpose of attaining any of its objects, to do any and all things and exercise any and all other powers not prohibited by law and either as or by or through principals, agents, attorneys, trustees, contractors, factors, lessees or otherwise, either alone or in connection with others; in general, to do or perform every act which shall be consistent with the purposes of this corporation.

ARTICLE III

The corporation is to have perpetual existence.

AFRICLE IV

The location and post-office address of the registered office of the corporation is 'Moscow, Latah County, Idaho.

ARTICLE V

The amount of the total authorized capital stock of this corporation is fifty thousand dollars (\$50,000) divided into five hundred (500) shares of the same common class of one hundred dollars (\$100.00) par value each.

ARTICLE VI

The incorporators shall serve as directors and shall manage and control the affairs of the corporation until the first meeting of share-holders for the adoption of bylaws and the completion of the organization.

ARTICLE VII

The number of directors of this corporation shall be not less than three (3) and no more than six (6) and the number, qualifications and terms of office, manner of election, time and place and manner of calling meetings and , owers and duties of the directors shall be prescribed by the bylaws.

ARTICLE VIII

The officers of this corporation shall consist of a president, vice-president, secretary and a treasurer and such other officers as the Epard of Directors of the corporation shall deem necessary, all of whom shall be shareholders who shall be elected by the Board of Directors and hold office during the pleasure of the Epard. The Epard of Directors in its discretion may elect the same person to the offices of secretary and treasurer. Each of the officers shall have such powers as may be conferred upon him by the bylaws of the corporation.
