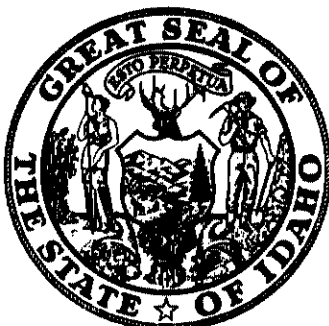
CERTIFICATE OF INCORPORATION OF

The undersigned, desiring to form a corporation pursuant to the provisions of the "Idaho Business Corporation Act", do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is: HIGH PERFORMANCE SPORTS, INC.

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

The corporation is formed for the purpose of transacting any and all lawful business for which a corporation may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The corporation shall be capitalized for \$50,000.00, and the aggregate number of shares the corporation shall be authorized to issue is 5,000, with a par value of \$10.00. There shall be one class of stock only.

ARTICLE V

Shareholders shall have preemptive rights as provided in Idaho Code Section 30-1-26, subject to the limitations therein contained.

ARTICLE VI

The initial registered agent of the corporation, and his address, shall be: Scott L. Hillam, 1385 E. 17th Street, Idaho Falls, Idaho 83404.

ARTICLE VII

The initial Board of Directors of the corporation shall consist of two individuals, who shall serve as Directors until the first annual meeting of shareholders, or until their successors are elected and have qualified. They are:

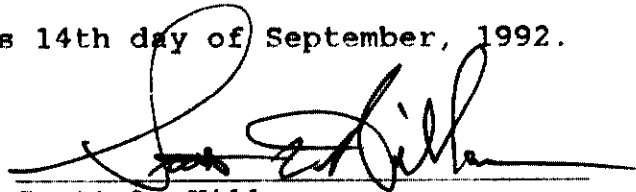

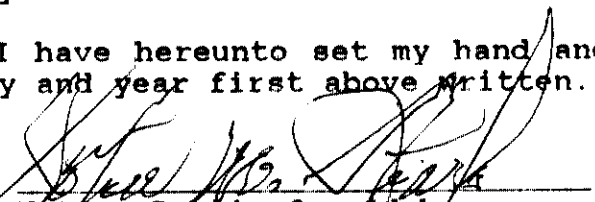
