ARTICLES OF INCORPORATION

OF

HAHN ENTERPRISES, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age and citizens of the United States of America, do hereby certify, as follows:

ARTICLE I

The name of this corporation is: HAHN ENTERPRISES, INC.

ARTICLE II

The term of existence of this corporation shall be perpetual.

ARTICLE III

The location and post office address of the registered office of the corporation in the State of Idaho shall be:

Location: 106 South Broadway, Blackfoot, Idaho.

Post Office Address: P. O. Box 172, Blackfoot, Idaho.

ARTICLE IV

The amount of the total authorized stock of this corporation shall be \$250,000.00, divided into 2500 shares of \$100.00 par value, non-assessable, common stock, and the rights appertaining thereto shall be in all respects equal; and the shares may be increased or decreased as provided by the laws of the State of Idaho.

ARTICLE V

Management of this corporation shall vest in a Board of Directors composed of three persons.

ARTICLE VI

The purposes of this corporation shall be:

Section 1. To engage in commerce, including but not hereby limiting, engaging in the automobile, mining, farming, livestock, and timber businesses; investing in real and personal property, including stock, bonds, debentures, notes, mortgages and other forms of securities, acquiring the same by purchase or otherwise, and disposing of the same by sale or other transfer;

Section 2. To engage in the business of renting real and personal property owned or otherwise held by the corporation;

Section 3. To acquire by purchase, or otherwise, all or any part of, or any interest in, the properties, assets, business, and good will of persons, firms, associations or corporations heretofore or hereafter engaged in any business for which a corporation may now or hereafter be organized under the laws of the State of Idaho, and to conduct the whole or any part of any business thus acquired.

Section 4. To borrow money, with or without the giving of security for the repayment thereof; to make loans or advances to person or persons, firms, associations or corporations in connection with the business of this corporation.

Section 5. To adopt, apply for and register, purchase, lease or otherwise acquire, and sell or otherwise dispose of, licenses or other rights with respect to trademarks, trade names, patents, patent rights, inventions, formulae, copyrights and trade secrets.

Section 6. To perform all acts as are necessary and expedient to accomplish the purposes of the corporation.
