ARTICLES OF INCORPORATION

of

EDGEWOOD ESTATES HOMEOWNERS ASSOCIATION, INC.

The following Articles of Incorporation are hereby adopted pursuant to the Non-Profit Corporation Act of the State of Idaho, (Chapter 3, Title 30, Idaho Code):

1. Name.

The name of the corporation is:

EDGEWOOD ESTATES HOMEOWNERS ASSOCIATION, INC.

2. Non-Profit.

This corporation is a non-profit corporation.

3. Duration.

The corporation shall have perpetual duration.

4. Purposes.

The corporation is formed for the purpose of owning, developing, operating and maintaining a culinary water system, to provide for snow removal and road maintenance, at cost, and any or all other lawful activities as may be for the mutual benefit of property owners in Edgewood Estates Subdivision, Teton County, Idaho, which are lawful and for which such a corporation may be incorporated under the Idaho Non-Profit Corporation Act.

5. Membership.

The corporation shall not issue shares of capital stock, but shall issue one class of membership certificates to

those property owners who are served by said water system and who agree to pay their proportionate costs thereof.

6. Registered Agent and Office.
