CERTIFICATE OF INCORPORATION

(Under Section 30-323 of the Not-For-Profit ~~SECRETARY OF~~ STATE Corporation Law)

Period of Duration (Perpetual)

1. The name of the corporation is TREASURE VALLEY COUNCIL FOR CHURCH AND SOCIAL ACTION, INC.

2. The Corporation has not been formed for pecuniary profit or financial gain, and no part of the assets, income or profit of the Corporation is distributable to, or enures to the benefit of its members, directors, or officers except to the extent permitted under the Not-For-Profit Corporation Law.

3. The purpose for which the Corporation is to be formed are:

(a) To stimulate the involvement of churches, religious and community organizations, and others of good will in the process of social change and improvement. It is non-profit, locally based but nationally affiliated as a Chapter of the National Council For Church And Social Action, Inc. It is interracial, interdenominational and interreligious.

It is committed to expressing the spirit of God and His Prophets and their concern for the poor, whatever the nature of this poverty. It is committed to the viewpoint that the Kingdom of Heaven on Earth can be created through the action of the Holy Spirit, mobilized through Christians, and other

religious persons of good will united through selfless service for the improvement of all humankind, through prayer, work and study at the local, national and international levels of society.

(b) To plan, develop, facilitate, administer and implement programs for community development without limitations in such fields as: community organizing, employment counseling, job development, housing, consumer education and participation, economic development, and other related supportive social services.

(c) To study community needs and develop research and evaluation procedures.

(d) To obtain maximum feasible participation of residents of the target community in community development activities.

(e) To cooperate with organizations such as community planning boards, local school boards, civic and social welfare agencies, and institutions serving human needs.

(f) To receive and disburse funds from governmental and private agencies which may be available in connection with stated purposes.

4. The office of the Corporation shall be located in the City of Boise, County of Ada and State of Idaho.

5. The territory in which the Corporation's activities are principally to be conducted is the City of Boise, County of Ada.

7. Rev. Dr. H. Lincoln Oliver, pursuant to 30-323, is hereby designated as agent of the Corporation upon whom process against it may be served. The post office address to which the Secretary of State shall mail a copy of any such process against the Corporation served upon him is P. O. Box 2651, 124 Broadway Avenue, Boise, Idaho 83701.

8. Prior to the delivery of this Certificate of Incorporation to the Department of State for filing all approvals or consents required by the Not-For-Profit Corporation Law or by any other Statute of the State of Idaho will be endorsed upon or annexed hereto.

9. (a) Said Corporation is organized exclusively for charitable, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).


(b) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170(c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Law).


(c) Upon the dissolution of the Corporation, and with the prior approval of the plan of dissolution by a District Court, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation in such manner,


or to such organization or organizations organized and operated exclusively for charitable, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.

10. The subscriber is of the age of nineteen years or over and are the same as the initial directors.
