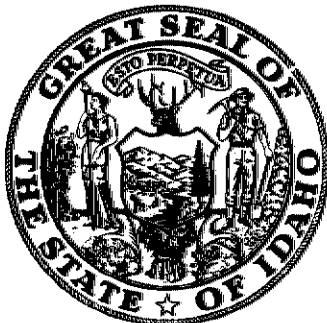

ARTICLES OF INCORPORATION

RYAN W. BOYER, P.A.

The undersigned natural person being of legal age, acting as incorporator under the provisions of the Idaho Professional Service Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is RYAN W. BOYER, P.A.

ARTICLE II

PERIOD OF DURATION

The duration of this corporation is to be perpetual.

ARTICLE III

PURPOSES AND POWERS

The purposes and the powers for which this corporation is organized are the performance of professional legal and related services as provided by the laws of the State of Idaho.

ARTICLE IV
CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue is fifty (50) shares of common stock, all of one class without par value.

ARTICLE V
INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of the corporation is 525 Park Avenue, Suite 2A, Idaho Falls, Idaho 83402; The name of the initial registered agent at that office is Ryan W. Boyer.

ARTICLE VI
DISTRIBUTIONS

The shareholder of the corporation may, from time to time, distribute to himself out of capital surplus of the corporation a portion of its assets, in cash or property, subject to the following provisions;

(a) No such distribution shall be made at a time when the corporation is insolvent or when such distribution would render the corporation insolvent;

(b) No such distribution shall be made unless it is authorized by the affirmative vote of the holders of a majority of the outstanding shares;

(c) Each such distribution, when made, shall be identified as a distribution from capital surplus and the amount per share disclosed to the stockholder receiving the same concurrently with the distribution thereof.
