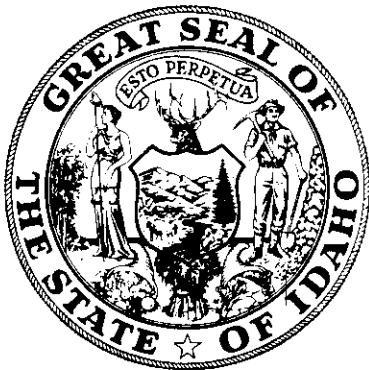

The First Step, Incorporated

The Articles of Incorporation of The First Step, Inc. are hereby amended as follows:

Article IV is to read as follows (The Amendment is the underlined portion)

The purposes of this corporation shall be to promote dance in North Idaho communities, produce programs of dance for regional and other audiences, sponsor visiting dance programs, workshops and scholarships, to raise funds to subsidize the above activities through donations, and to do all things related to promoting the art of dance singly and in groups. This corporation is organized exclusively for religious, charitable scientific, literary or educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

Article V is to read as follows (The Amendment is underlined)

This corporation shall have all the powers granted to general business corporations under the laws of the State of Idaho. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code.

These amendments are hereby passed at a meeting of the membership, on February 1, 1980, and the filing fee approved to be paid
