Know All Men by These Presents:

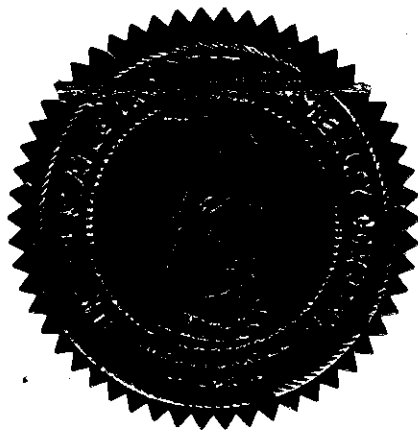
That the UNITED STATES INSTALLMENT REALTY COMPANY,-----
