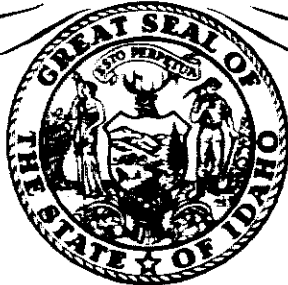

SMITH, the undersigned, hereby certify that we are, and at all times mentioned were, the president and Secretary, respectively, of North End Realty, Inc., an Idaho corporation organized and existing under and by virtue of the laws of the State of Idaho with its registered office located at Boise, Idaho.



That on September 18, 1970 at a special meeting of the stockholders, legally called, the stockholders determined that it would be advantageous to the corporation to change its name from North End Realty, Inc. to Richard B. Smith Real Estate, Inc. Pursuant thereto the stockholders at said meeting unanimously voted in favor of amending the Articles of Incorporation as follows:

WHEREAS, it is to the best interest of the corporation that the name thereof, to wit: North End Realty, Inc. be changed to Richard B. Smith Real Estate, Inc., NOW, THEREFORE,

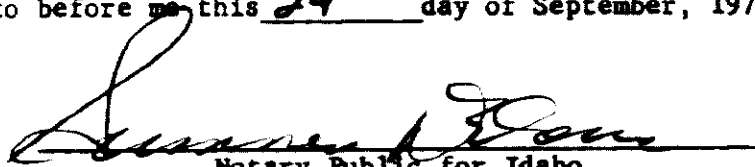
