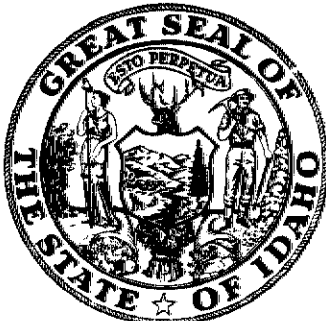

III. PURPOSE: The purpose of this corporation is hereby enlarged to add and include the following subparagraph:


(10) To engage in any lawful purpose prescribed by the Board of Directors and/or as set forth in the Bylaws of Nevill Enterprises, Inc.

amendments were adopted by a unanimous vote of all shareholders on December 25, 1996, accordingly have hereunto set out hands and seals this 28th day of February, 1997.


