ARTICLES OF INCORPORATION

The undersigned, acting as the incorporator of a nonprofit corporation ("Corporation") organized under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code ("Act"), adopts the following Articles of Incorporation for the Corporation.

Article I Name

The name of the Corporation is "Idaho Association of Mortgage Brokers, Inc."

Article II Nonprofit Status

The Corporation is a nonprofit corporation.

Article III Period of Duration

The period of duration of the Corporation is perpetual.

Article IV Initial Registered Office and Agent

The location of this Corporation is in the City of Boise, County of Ada, State of Idaho. The address of the initial registered office is 988 Longmont Avenue, Suite 110, Boise, Idaho 83706, and the name of the initial registered agent at this address is Kristin K. Colfer.

Article V Purposes

The purposes for which the Corporation is organized and will be operated shall be:

Section 1 Primary Purposes

ARTICLES OF INCORPORATION OF IDAHO ASSOCIATION OF MORTGAGE BROKERS, INC. - 1

Section 2 Limitations

- 2.1 The Corporation shall have no net earnings inuring to the benefit of any member.
- 2.2 The associated mortgage brokers shall have as their object the betterment of the conditions of those engaged in such pursuits, the improvement of the grade of their services, and the development of a higher degree of efficiency in their respective occupations.
- 2.3 The Corporation shall not engage in a regular business of a kind ordinarily carried on for profit.

Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefor, may not at that time lawfully carry on or do.

Article VI Members

The Corporation shall have members who shall have such rights as are provided in the Act and the bylaws and are consistent with the management authority that these Articles of Incorporation grant to the Board of Directors of the Corporation. Any person or legal entity may become a member of the Corporation upon payment of the annual dues or such other consideration, if any, as fixed by the Board of Directors.

Article VII Board of Directors

The affairs of the Corporation shall be managed by its Board of Directors. The Board of Directors shall consist of not less than three (3) individuals, each of whom, at all times, shall be a member of the Corporation or a shareholder in a legal entity which is a member of the Corporation. The actual number of directors shall be fixed by the Bylaws of the Corporation. Other than the directors constituting the initial Board of Directors, who are designated in these Articles of Incorporation, the directors shall be elected or appointed by the existing directors in the manner and for the term provided by the bylaws of the Corporation.

Article VIII Membership Dues

Any such assets not so distributed shall be distributed by the district court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such
