

ARTICLES OF INCORPORATION

OF

Computer Sales & Services, Inc.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation is **Computer Sales & Services, Inc.**

ARTICLE TWO

The period of the corporation's duration is perpetual.

ARTICLE THREE

The purpose or purposes for which the corporation is organized is to:

- (1) Engage in the retail sales and leasing of computers, computer accessories, including but not limited to monitors, keyboards, printers, software, and the like. In addition, services will be offered to individuals, businesses and other entities. Services will include the installation of computers and computer components, repairs and servicing of computers and computer components.
- (2) To do all and everything necessary and proper for the accomplishment of the objectives hereinbefore enumerated or necessary or incidental to the protection and benefit of the corporation.

The foregoing clauses shall be construed both as purposes and powers and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of the corporation and are in addition to and not in limitation of the general powers conferred by the laws of the State of

Idaho; provided that no purpose stated above will authorize this corporation to be organized for or to transact any business in this state which is prohibited by the Idaho Business Corporation Act, as now written or as hereafter amended; and further provided that no purpose stated above will authorize this corporation to violate any other law, statute, regulation or ordinance of Idaho or the Government of the United States of America.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) shares of common stock with no par value.

ARTICLE FIVE

The name of the initial registered agent is Dennis Henrie whose office is located at 1339 E. 17th Street, Idaho Falls, Idaho 83404.

ARTICLE SIX

The corporation will not commence business until it has received for the issuance of shares consideration of the value of at least One Hundred Dollars and No Cents (\$100.00) consisting of money, labor and property actually received.

The number of directors constituting the initial board of directors of the corporation is two (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:

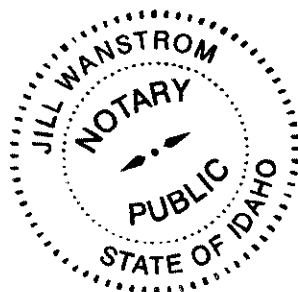
