

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, FRED E. LUKENS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

THE SANTOOTH GRAZING ASSOCIATION

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the 12th day of 1931, original articles of amendment, as provided by Section 28,34,36 of Chapter 262 of the 1929 Session Laws of the State of Idaho, reducing the capital stock from fifty thousand dollars (\$50,000) to twenty-five hundred dollars (\$2,500), divided into five thousand (5,000) shares of the par value of fifty cents (50‡) each. and that the said articles of amendment contain the statement of facts required by law, and are recorded in Book A-25 of Record of Domestic Corporations of the State of Idaho.

I THEREFORE FURTHER CERTIFY, That the capital stock of The Samtooth Grazing Association has been reduced from fifty thousand dollars (\$50,000) to twenty-five hundred dollars (\$2,500), divided into five thousand (5,000) shares of the par value of fifty cents (50¢) each.

ARTICLES OF REDUCTION OF CAPITAL' STOCK

The ARTICLES OF REDUCTION OF CAPITAL STOCK of Sawtooth Grazing
Association , a corporation organized and existing under the laws
of the State of Idaho, show, the undersigned, respectively President and
Secretary of Sawtooth Grazing Association, a corporation, and
certify:
1. That Sawtooth Grazing Association is a corporation organized
and existing under the laws of the State of Idaho, having its principal place
of business at shoshore , Lincoln County, Idaho.

County, Idaho, notice of a special meeting of the stockholders of the Sawtooth
Grazing Association , a corporation, to each of the stockholders of the
said corporation, at their respective last known addresses, which said notice
set forth in substance the following: Time of Meeting: One P. M.
January 5, 1931 ; Place of Meeting Legion Memorial Building, Shoshone, Idah
Purpose of Meeting: To consider and vote upon a proposed reduction of the
capital stock authorized for said corporation from \$50,000.00
to 32,500,00
That the said notice was mailed as aforesaid, more than thirty day:
prior to the time set for said meeting.

The capital stock of this corporation shall be Twenty-Five Hundred Dolkars (\$2,500.00) Dollars, divided into five thousand shares of the par value of fifty cents (50¢) each.
