CERTIFICATE OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF THE PLEASANT VALLEY IRRIGATION COMPANY, LTD.

KNOW ALL MEN BY THESE PRESENTS:

That we the undersigned, the President and Secretary, respectively, of Pleasant Valley Irrigation Company, Ltd., do hereby certify as follows:

Pleasant Valley Irrigation Company, Ltd. is a corporation duly organized and existing under and by virtue of the laws of the State of Idaho.

The annual meeting of the shareholders of said corporation was duly held at the office of the principal place of business, 530 First National Bank Building, Boise, Idaho, on March 2, 1968, beginning at the hour of 1:30 o'clock P.M. for the purpose of considering and acting upon the proposition of amending the Articles of Incorporation to extend the corporate existence which has expired or change the corporate existence to perpetual life. Notice of said meeting stating the specific purpose thereof was given as required by law. At the time of said meeting, the total number of shares of said corporation entitled to vote was 1521. There were present at said meeting 1101 shares.

At said meeting a resolution was regularly proposed, voted upon and adopted by the unanimous vote of all stockholders present amending the Articles of Incorporation of said corporation. Following is a full, true and correct copy of the resolution of said stockholders amending the Articles of Incorporation:

BE IT RESOLVED, that the Articles of Incorporation of Pleasant Valley Irrigation Company be amended by amending the fourth paragraph thereof to read as follows:

"FOURTH

The term of existence of this corporation shall be perpetual."

The resolution was unanimously adopted by the vote of 1101 shares of stock representing more than two-thirds of the issued and outstanding shares which total 1521 shares of stock.
