1. The name of the corporation is *G.L.B., INC.*

DURATION

2. The period of it's duration is perpetual.

PURPOSE

(b) Except as otherwise prohibited by Idaho law, the corporation, in furtherance of it's corporate purposes set forth above, shall have all of the powers necessary and proper for the effectuation of any and all legitimate enterprises of the corporation, subject to any limitations provided by the laws of the State of Idaho.


