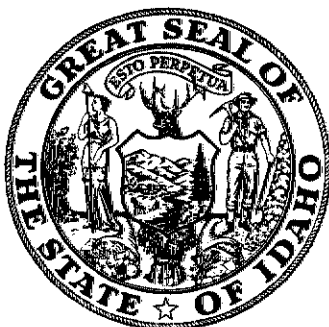

We the undersigned, desiring to form a non-profit corporation under the statutes of the State of Idaho, do hereby make, subscribe, and acknowledge as follows:

ARTICLE ONE

NAME

The name of the corporation is DEPARTMENT ASSOCIATION LADIES  
AUXILIARY PATRIARCHS MILITANT INDEPENDENT ORDER OF ODD FELLOWS, INC.

ARTICLE TWO

NON-PROFIT PURPOSE

This corporation is organized exclusively for operating a fraternal association for social, benevolent and chairtable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code. No part of the corporate assests, income, or profit shall be distributable to, or inure to the benefit of its officers, or members except to the extent permitted for a non-profit corporation under the non-profit corporation laws of the State of Idaho and under Section 501 (c) (3) of the Internal Revenue Code.
